Considering that the zionist army steals and occupies more and more palestinian territories, notably through the control of  $\frac{2}{3}$  of the Gaza strip and through quadi-daily raids in the West Bank.

  between the BDS movement and the self-management of academic institutions
- The continuation of the development of relationships with pro-Palestine groups with the objective of creating a strong and convergient pressure tactic to respond to the calls for BDS
- The preparation of a training camp in early fall with other groups after the October 7th mobilization
- The preparation of mobilisation tours at the beginning of the fall semeste with the preparation of a BBDS motion to be adopted by the associations.

#### • Fall 2025

Considering that SOGÉÉCOM highlights that decisions made during congress must be made in a spirit of respect of procedures and mutual respect, that accounts for diverging opinions and allows each delegation to defend their proposals.

Considering that any efforts to shut down debate or manipulate its direction to reach a predetermined result must be denounced.

#### 6. Discussions on the notices of motion

#### 6.1. Notice of motion on the indicative vote

That the section "indicative vote" be added to the Code of Procedure in Section V "Dilatory proposals" "16- Indicative Vote."

#### "Definition:

Indicative votes are a type of dilatory proposals aiming to survey the room on a given topic. An indicative vote must specify the topic of the vote, the delegations who hold voting power, and the voting options. An indicative vote only serves an informative purpose for the Congress and does not hold decisionnal weight.

Indicative vote proposals are admissible in plenary (article 34 : Plenary).

#### **Conduct of the vote on indicative vote:**

The indicative vote proposal must be seconded. It can be debated or amended and requires simple majority of the associations which will be able to vote once the indicative vote is conducted. Once the indicative vote proposal is adopted, the facilitator conducts the indicative vote on the question.

#### Conduct of the indicative vote

The question voted upon is suggested by the association demanding the indicative vote. If the question regards multiple choices, each choice is to be voten on, one after the other. The indicative vote is counted according to the same dispositions as the voting section of the CRUES Code of Procedure. The vote is consigned in the minutes, even if non-decisional."

That article 34 of the Code of Procedure be amended as follows:

Add: « and indicative votes proposals » in article 34 so that it reads as follows:

"A plenary is a period of discussion between delegations on a specific topic. The proposal for a plenary should specify the topic of the discussion and its duration. The proposal for a plenary cannot be debated, but can be amended to change the topic or duration. Only privileged proposals and indicative votes proposals are admissible in plenary. However, a proposal to close the plenary session is also admissible in accordance with the modalities of the preliminary question."

That option d) "Indicative vote" be added to article 21 so that the list reads as follows:

- a) Reference
- b) Deposit
- c) Preliminary question
- d) Indicative vote
- e) Tabletop

#### 7. Political Positions

Proposal to adopt the following position against the *comité des "sages"* in anticipation of the release of its report:

Considering CRUES principle no. 11 for the abolition of the cisheteropatriarchy and discrimination based of gender identity and/or expression, sexual orientation and sexual and/or bodily diversity;

Whereas the so-called 'comité des sages' recently turned in its report, the 'findings' of which will most likely promote backwards transphobic rhetoric;

Whereas this committee is composed of several people with direct links to transphobic groups and personalities such as PDF Québec and the late Diane Guilbault, as well as right wing movements such as the pro 'secularism' movement;

Considering the transphobic movements in so-called 'québec' and the increasingly frequent collaboration of mainstream political parties with these movements, especially in the case of the Parti Québecois, Bloc Québécois and – of course – the CAQ, who created the committee:

Considering the danger of the promotion of this essentialist transphobic rhetoric by the committee in the context of these increased collaborations between transphobic actors and the political sphere;

#### Be it resolved:

That, in the case of the very likely eventuality that the report's conclusions encourage the government to repress the human rights of trans people, CRUES publish – with immediacy – a denunciation of this attack;

That CRUES denounce the idea of a trans 'question', according to which the legitimacy and the human rights of trans people would be an issue to debate;

That CRUES denounce the existence in and of itself of this committee as a forefront of this questioning of trans identity;

That CRUES position itself in favour of universal access with no reserves to gender affirming care, notably HRT (Hormone Replacement Therapy);

That CRUES hold in contempt and never collaborate with any group the perspectives of which are transphobic, of course including so-called 'feminist' perspectives that exclude trans and/or gender non-conforming people, commonly known as TERFs;

That CRUES collaborate with queer/trans groups to signal boost their messaging to student bodies across so-called 'québec', especially through social media and – in the eventuality that it's functional – through its newspaper;

Whereas Concordia students have reformed the 2015 movement Concordia Against Tribunals (CATS) to combat this heightened repression of student activism and academic freedom;

Whereas this movement has accrued a number of legal expenses in its mission to defend Concordia students facing penalties for their activism;

Whereas CRUES is a union fighting for students' interests and engaging in combative syndicalism which has mandates in support of the Palestine solidarity movement and against the repression of students at Concordia (see CRUES position on Cops off Campus);

Whereas CRUES has given itself the mission of supporting students facing legal or academic penalties through various means including but not limited to its Legal Committee;

Be it resolved:

That CRUES state its support for the CATS campaign;

That CRUES donate 1 600\$ to CATS to aid with expenses accrued in the fight against the repression of Concordia students;

Depuis le départ de Rémi Grenier, le journal a été au point mort, les personnes se faisant élire sur le comité se sentant souvent désemparé.e.s, seul.e.s face à la tâche, sans trop savoir où commencer, menant au désintérêt de nombreuses personnes du projet de la CRUES. Pour cette raison, je m'engage à au moins une année ferme d'engagement dans le journal, et je suis presque certain de vouloir le faire pendant deux ans.

Mon but serait de recréer le journal et d'en faire une réelle institution de la gauche étudiante radicale. Campagne ou pas campagne, grève ou pas grève, victoire ou défaite, le journal sera là en renfort de tout. La présence d'un journal fort enlèverait le fardeau au comité information de devoir expliquer l'entièreté de l'argumentaire en un tract, et permettrait au comité mobilisation d'avoir une version plus longue d'argumentaire à distribuer. De plus, l'idée d'un journal étudiant pan-provincial a, selon moi, un potentiel d'attrait qui permet d'intéresser des personnes non-impliquées à s'intéresser à nos luttes.

Mon plan incluerait également de mobber vraiment fort pour le comité journal à Rimouski, profitant de ma présence pour mobber des gens de mon programme. Je m'engage à réaliser une première édition, prête à imprimer pour la rentrée des cégeps en fin août, au meilleur de mes capacités.

Réflexions sur le premier Débordement.

La première et unique édition du débordement fut apprécié et critiqué sur quelques aspects que je trouve important de souligner à nouveau pour expliquer mon approche. Il va de soi que tous ces aspects seraient à discuter avec de potentiels camarades.

Le journal était beau. Malgré quelques soucis de taille de police d'écriture et de choix de couleurs pour certaines pages, le journal impressionnait visuellement, et c'est un aspect à viser à nouveau. Soyez avertis que mes compétences de graphismes sont de -3, j'apprécierais tout coup de main à ce niveau-là!

Mais le journal était éparpillé. Malgré des articles d'une grande qualité sur la cause des stagiaires, il y avait également des textes de réflexions, parfois académiquement trop avancés, parfois, parfois sans rapport avec les campagnes en cours. Bien que les textes de réflexion aient et devraient conserver une place importante dans notre mouvement, il m'apparaît important de prioriser la vision d'un journal comme un outil de mobilisation, de transmission d'analyse, d'argumentaire et d'informations peu présentes dans les médias de masse. Un contrôle éditorial plus serré du contenu d'appel de textes s'imposera logiquement de cette perspective.

Il serait intéressant réfléchir à la faisabilité d'un journal sans appel de textes, avec uniquement des textes faits maisons, comme l'ont fait certains collectifs durant la dernière année : Rage climatique, Convergence des Luttes AntiCapitalistes (CLAC), Désinvestir pour la Palestine(D4P), par exemple. Ce ne serait possible qu'avec un comité journal plus établi, avec plus de membres, mais une possibilité de création d'expertise à envisager sur le long terme.

Aussi, pour faire place aux textes de réflexions ne correspondant pas aux besoins du Débordement, il m'apparaîtra super excitant de publier abondamment ces textes sur les réseaux sociaux du Débordement et sur nos autres plateformes.

#### Conclusion

Donc voilà! J'ai jamais fait de journal de ma vie, comme j'avais jamais vraiment fait de mobilisation de qualité avant de rejoindre le comité mobilisation de la CRUES. Mais comme je suis resté pendant 2 ans ferme au comité mobilisation, malgré d'innombrables crises internes, je peux vous promettre que je ne lâcherai pas le morceau, que je prendrai la responsabilité de la tâche et des budgets octroyés par les associations membres avec un sérieux et une discipline révolutionnaire, qu'importe la campagne, qu'importe le drama.
